Permission to Publish Contract

Permissions to publish, exhibit, broadcast or quote from materials in the Watzek Library Archives & Special Collections requires written permission of the Head of Archives & Special Collections or another appointed agent of the College. The rules governing use of materials in the collections are fully stated in the Archives & Special Collections Regulations of Use and Registration Form, which researchers must sign. A copy of the Registration Form may be kept by the researcher; the original is maintained by Lewis & Clark College.

Subject to the following condition, I/we request permission to reproduce materials from the archival, manuscript (non-book) collections of the Watzek Library Archives & Special Collections, listed below. (Similar use of printed books does not usually require specific permission, though copyright laws may apply. A few printed books, however, particularly those with extensive manuscript annotations, are placed under archival/manuscript rules.)

Conditions

1. Credit line for all materials: Courtesy of Lewis & Clark College Aubrey Watzek Library Archives & Special Collections. This credit must be included for each reproduced image or in each footnote or endnote reference. Additional credits may be necessary if so requested by donors.
2. Permission is granted for one-time use only. Materials may not be reused without the written permission of the appropriate agent of Watzek Archives & Special Collections or other appointed agent of the College.
3. Lewis & Clark College reserves the right to make charges for the use of materials as it deems appropriate in any individual case.
4. In the case of printed materials, the undersigned undertakes to send the Watzek Archives & Special Collections proofs or tear sheets of each title page and page(s) containing reference to and acknowledgements of the materials listed below. In the case of motion picture films, slideshows, videos, homepage and other non-book publications, the undersigned undertakes to send Watzek Archives & Special Collections still photographs, photocopies, or printouts of the title frame or homepage and the frame(s) or page(s) showing credits.
